

MSc in Data Science and Machine Learning (MDSML) Tuition Fees Structure for 2023 Intake (Singapore Citizen/Singapore Permanent Resident Students)

Starting from AY2023/2024, all Singapore Citizens and Singapore Permanent Residents, enrolling into the MDSML programme will be automatically extended with a 15% tuition fee rebate.

❖ Acceptance Fee:

Early Admission	SGD 5,350 (inclusive of 7% GST) <i>*Acceptance fee paid in 2022.</i>
Regular Admission	SGD 5,400 (inclusive of 8% GST) <i>*Acceptance fee paid in 2023.</i>

This is a one-time payment upon offer acceptance. Acceptance fees is non-refundable and non-transferrable.

- ❖ Full-time and part-time Singapore Citizen / Singapore Permanent Resident students will be billed based on the number of courses read per semester (pay by per-course fee).
- ❖ Singapore Citizens and Singapore Permanent Residents who enrolled to the SSG-funded courses which are skills-based and industry-relevant may be eligible to receive up to 70% subsidy. For Singapore Citizens aged 40 years old and above, the subsidy may be up to 90%.
- ❖ Please note that SSG funding can only be used for at most 5 elective courses.
