- Starting from the AY2024/2025 intake, NUS alumni (regardless of nationality) enrolling in the MSc in Mathematics by Coursework will automatically receive a **20%** full tuition fee rebate. Non-NUS Alumni Singapore Citizens (SCs) or Singapore Permanent Residents (SPRs) admitted to MSc in Mathematics by Coursework will be granted a **15%** full tuition fee rebate.
- Please note that the rebate will be automatically applied to the tuition fees. SCs and SPRs students, as well as NUS alumni, do not need to submit a separate application for the rebate.
- All Fees quoted above include prevailing Goods and Service Tax (GST).
- Fees paid are **non-refundable or transferrable** in the event of withdrawal of offer made, non-completion of the programme or switching to other coursework programme by the students.
- Students who wish to read more than 80 Units or who failed a course and need to repeat / replace a course will be required to pay additional course fee.
