- The fees listed are in Singapore Dollars (SGD). Amount is subject to the prevailing Goods and Services Tax (GST) rate.
- For August 2023 intake (AY2023/2024), all Singapore Citizens, Singapore Permanent Residents and NUS Alumni (regardless of nationality), enrolling into the MSc in Mathematics by Coursework programme will be automatically extended with a 15% tuition fee rebate.

****From year 2024, Singapore Citizens and Singapore Permanent Residents will receive a 40% rebate on the remaining balance of tuition fees.**

- The rebates are intake-base. They will be automatically applied to the tuition fees, and eligible students do not need to apply for them.

Rebates will not be applicable to SC/SPR/NUS Alumni students who read more than 40 units or obtain a 'F' or 'CU' grade and need to repeat/replace. For such cases, the student will need to pay for the additional course by the per-course fee.

- Fees paid **are non-refundable or transferrable** in the event of withdrawal of offer made, non-completion of the programme or switching to other coursework programme by the students.
- Students who wish to read more than 40 units or who failed a course and need to repeat / replace a course will be required to pay additional course fee.
